Subject: PRE-SCHOOL AND AFTER-SCHOOL CARE SERVICE – School Year 2026/2027

With reference to School Circulars no. 231 of 4 August 2026 and no. 4 of 2 September 2026 concerning the school calendar for the 2026/2027 school year and the start times of teaching activities for the 2026/2027 school year, we hereby inform you that the **Pre-School and After-School Care services** will start according to the following arrangements:

PRIMARY SCHOOL – PRE-SCHOOL CARE - Starting Monday, 14th September 2026

(Entry permitted from 7:30 a.m. to 8:00 a.m.)

Via Filzi/Garbatola Monday to Friday, from 7:30 a.m. to 8:25 a.m.
(Entry permitted from 7:30 a.m. to 8:15 a.m.)

PRIMARY SCHOOL – AFTER-SCHOOL CARE - Starting Thursday, 17th September 2026

(Students may leave from 5:15 p.m.)

(Students may leave from 5:15 p.m.)

PRESCHOOL – AFTER-SCHOOL CARE - Starting Monday, 14 September 2026

IMPORTANT: The 6:00 p.m. pick-up time is mandatory. Parents are strongly requested to be punctual and to comply with the established hours. In the event that the parents or their authorized delegates are not present to collect the child at the end of the service, the student will remain at the school premises and, in the event of a prolonged delay, will be handed over to the relevant police authorities. Any additional costs incurred by the service as a result of late pick-ups may be charged to the responsible parent.

For all other users of the service, please note that the maximum monthly fees established by the Municipal Council through Resolution no. 158 of 27 November 2025 are as follows:

PRESCHOOL – AFTER-SCHOOL CARE

Residents: **€39.00**

non-residents: **€42.00**

Payment method: 3 instalments (September–December; January–March; April–June).

For the month of September only, the fee will be calculated proportionally based on the actual number of days the service is available.

PRIMARY SCHOOL – PRE-SCHOOL CARE

Fixed monthly contribution:

Residents: **€37.00**

Non-residents: **€40.00**

Payment method: 3 instalments (September–December; January–March; April–June).

For September and June only, the fee will be calculated proportionally based on the actual number of days the service is available.

PRIMARY SCHOOL – AFTER-SCHOOL CARE

Fixed monthly contribution:

Residents: **€39.00**

Non-residents: **€42.00**

Payment method: 3 instalments (September–December; January–March; April–June).

For September and June only, the fee will be calculated proportionally based on the actual number of days the service is available.

PRIMARY SCHOOL – PRE-SCHOOL + AFTER-SCHOOL CARE - (attendance at both services)

Fixed monthly contribution:

Residents: **€64.00**

Non-residents: **€68.00**

Payment method: 3 instalments (September–December; January–March; April–June).

For September and June only, the fee will be calculated proportionally based on the actual number of days the service is available.

If the Pre-School and After-School Care services start on different dates, the fee will be calculated proportionally by applying the rates established for each individual service.

Except for the provisions applicable to September and June, if enrolment begins during the month, the fee will be charged at 100% if the service starts on or before the 15th of the month. If the service starts after the 15th, 50% of the fee will be charged.

Please note that enrolment in the service is binding. Therefore, the relevant fee will also be charged in the event of non-attendance. Users are therefore advised to carefully check the enrolments submitted and to communicate any cancellations before the services begin, to avoid being charged the applicable fees.

In the event of withdrawal during the school year, the fee for the current instalment must still be paid and no refund will be issued, except in documented cases of health-related reasons.

Further specific communication regarding payment of the service fees will be sent by email.
